Craft, Royal Arch and Mark Resumption of Masonic Activities





Brethren, the following announcement was included in the 3rd Edition of the 1st Rising from UGLE issued last week, which states "....we are content that there is presently no requirement to extend the suspension in England (from 17th July), and accordingly Masonic meetings may begin again from this date.....Meetings may only be held in obedience to prevailing National Guidance, local rules from Hall and Venue Companies, and in conformity with the General Guidance given, jointly with Mark Masons' Hall, below"

General Guidance for the Resumption of Masonic Meetings

- 1. At all times, the judicious use of common sense is to be encouraged.
- Prevailing Government guidance (UK, Wales or Scotland, as appropriate) must be followed, in addition to local rules from Masonic Hall companies etc.
- Disposable/medical gloves should not be worn. They are far more likely to spread the virus (if any is present) unless used correctly as they are in medical circumstances by trained professionals. Regular handwashing and avoiding touching your face are far more effective.
- In the absence of definitive Government guidance, members who wish to wear face masks during meetings are to be allowed to do so.
- Nobody, particularly elderly or vulnerable members, should feel coerced into attending meetings – irrespective of their office.
- 6. The current, absolute, maximum number of members allowed to physically attend a meeting in England will be 30 but different limits may apply elsewhere. This limit will be determined by Government guidance and by the regulations set by the masonic hall or other meeting venue as judged by, for example, the dimensions of meeting spaces, relative ventilation etc.
- In the event of a meeting being oversubscribed, the Lodge/Chapter/or equivalent Unit should decide who attends and should do so equitably.
- Members who are unwell or have recently been unwell and those who are under advice to self-isolate must not attend meetings.
- 9. For the time being, there is to be no singing in meetings.
- There are to be no Festive Boards after meetings. Presently, guidance does not allow for mass dining but as soon as the guidance changes to allow this, dining may then be offered.

"...At the instruction of the Pro Grand Master
/ Pro First Grand Principal, temporary
alterations have been made to the
ceremonies of Initiation and Passing, and to
the Opening and Closing of a Royal Arch
Chapter as well as their respective
ceremonies of Installation. These are to be
observed by any Lodge or Chapter that wishes
to meet and perform such ceremonies until
Lockdown restrictions are eased to permit
normal working.

At the present time, the Ceremony of Raising should not be performed until Lockdown Restrictions ease to allow it to proceed without alteration"

Our PGM Robert Vaughan states "Before any meetings can take place, Hall Management Committees must demonstrate that each Centre is Covid secure. In addition each brother must consider his own circumstances, and no one should be encouraged to resume masonic activity earlier than is his wish

Specific guidance from the Provincial Office will be published and sent out over the next few days to every member.

Clearly the early priority is given to the preparation of the reopening our meeting places - where essential and authoritative advice in respect of the cleaning and clear communication of the responsibilities on all users, before and after every event is available. All lodges are encouraged to defer discussions until the formal notice and guidelines have been published.

Note that the Grand Secretary General of the Supreme Council of Ancient and Accepted Rite ("Rose Croix") explicitly has confirmed that masonic activity within the Ancient and Accepted Rite <u>remains suspended</u> in England and Wales.

Bro Steve Holmes - My Covid-19 story



"At the end of March I was not feeling well and had trouble breathing - it got worse so I called an ambulance and was taken into hospital leaving my family behind, as my wife Laura was not allowed to come with me. They told me that I had viral pneumonia and I was tested for Covid 19 which came back positive - this was the start of my real problems.

After struggling for a few days with my oxygen levels they sedated me and put me onto a ventilator, were I remained for five weeks. At the end of May, Laura and my family were told to prepare for the worst. But I was fighting, and a week later I regained consciousness, to the point that I could speak to Laura on the phone for the first time in five weeks.

During my recovery I then had a stroke and was transferred to the Stroke clinic in Evesham where I started my full recovery. I targeted to be home for my granddaughter's birthday which after a lot of hard work I achieved.

I still have a lot to do having to learn to walk and talk again but I am making good progress. My Lodge - Page Lodge No. 3378 have been amazing and given my family so much support during my illness. My sincere thanks go to all my friends, members of my Lodge and Family - and above all the amazing NHS staff who have and continue to help my recovery.

I am now looking forward to the life I nearly lost and hopefully going into the Chair of Page Lodge next year.


